Bivona is a nonprofit organization that offers a safe, welcoming place where children who have been sexually or physically abused can begin their journey of healing. Bivona facilitates a multidisciplinary team of professionals that includes 23 agencies and provides the physical space where cases of child sexual and severe physical abuse, whenever possible and practical are investigated, evaluated, and treated. In 2021 alone, Bivona evaluated nearly 2,000 children. Bivona also leads the Monroe County Child Fatality Review Team, which evaluates all sudden, unexplained or unexpected child fatalities.
