

Message From Our Board Chair and Executive Director

Dear Friends,

Last year, our Team of 22 partner agencies saw just under 2,000 children, the highest number of children we've seen in any one year since Bivona Child Advocacy Center opened its doors In 2004. This number does not keep growing because abuse has become more prevalent, rather it is growing because the community has become more aware of the important role that we play in responding to abuse. Our partners are bringing more children to our door, and we take comfort in knowing that more children are experiencing our coordinated and trauma-sensitive services when they need them. The children we serve may have directly experienced abuse or lived in a household impacted by child abuse or domestic violence. By working together, our Multidisciplinary Team-- including forensic interviewers, social workers, investigators and other law enforcement personnel, family advocates, medical and mental health professionals, administrative staff and volunteers-- prove that by working as one we can provide children and families with the highest quality of care and make a real difference in a child's future.

Only **one in three** adults say that they would believe a child who disclosed sexual abuse to them today. But the people who work within and around this organization would never turn away from a child in need. We are there, on the front lines and in countless other roles, to listen to and believe children, striving to keep all children in our community safe and free from abuse. This circle of support grows wider every year, including more staff and Team members, volunteers, supporters, and the 800 professionals who attended our annual Child Abuse Summit in April 2017. There is tremendous strength in these numbers.

One of the toughest things to see and understand about child abuse is the way it can impact entire families, not just children. The effects of abuse can be severe and long-lasting, and we know that support in a variety of forms is needed to help children and their families heal. In 2017, we changed the name of our Victim Advocacy program to Family Advocacy to better articulate this work and the needs we see each day In the families we serve. In addition, our Team added **four** Family Advocates to join Family Advocacy Coordinator Sara White-Smith. Our goal is that every child who comes to Bivona receives Family Advocacy services, because we know that children do not heal alone, they do it through the support of their families.

In a year when our Team encountered many instances of horrific abuse, we were also introduced to true heroes. By looking for and recognizing the strengths of the children and families we serve, we are doubling our impact - doing together what was once done alone and realizing the amazing power of the **strength in numbers**.






